Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>FastLending.com does not share with affiliates.</li> </ul>	
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li><i>Non-affiliates we share with can include participating retailers.</i></li> </ul>	
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li><i>FastLending.com does not jointly market.</i></li> </ul>
